South Central - Clemelia Richardson, PhD, MSW

As a recognized leader of public health in Arkansas for many years (Medical Director, Women's Health, Arkansas Department of Health (ADH)), Dr. Riddell is strategically positioned to take full advantage of the opportunity to learn from his experience with CityMatCH to improve his leadership skills and team building continuing to helping disadvantaged women deal with numerous public health and safety issues.

He is the architect of a unique statewide IUD training program where he has provided intensive, one-on-one IUD training including didactics, inanimate models, and a minimum of ten supervised "client" IUD insertions before "certification" resulting in over 40 ADH practictioners highly trained to safely place IUDs and implants in clients at over 90 ADH Title X funded clinics in all



place IUDs and implants in clients at over 90 ADH Title X funded clinics in all 75 counties in Arkansas. Dr. Riddell received the National Family Planning Superstar Award in 2014.

Other areas of special interest with proven leadership-driven results include: immunizations (MMR, Influenza, HPV), maternal mortality, teen pregnancy, reproductive health education, telemedicine, implementation science, capacity building, clinic efficiency, well-woman preventive services, perinatal services, NICU levels, < 39 weeks NMI scheduled delivery, state MMRC and maternal safety bundle adoption, and other QA projects.

I feel that my experience with CityMatCH will enhance my ability to help others in need. The ability to see the "big picture", "connect the dots", and create "win-win" solutions to public health challenges is a key attribute that I value!

In 2006, Mrs. Evans decided to combine her social work experience with financial and business expertise and in 2008 was awarded her Master of Business Administration from Texas Woman's University in Denton, Texas. After working in higher education, she realized her passion for maternal and child health which lead to her program management position with the Fort Worth Texas Healthy Start Program. While working as program manager, her success managing the Healthy Start program lead to her promotion to Healthy Start Federal Project Director. After working for Healthy Start for several years, in 2013 Mrs. Evans accepted a position with the City of Pasadena as the Program Coordinator for the Black



Infant Health Program. In 2016, Mrs. Evans was appointed as Acting Maternal, Child and Adolescent Health Program Director while continuing to oversee all program operations of the Black Infant Health Program.

In 2018, Mrs. Evans transitioned from the Acting Maternal, Child and Adolescent Health Program Director for the City of Pasadena to the permanent director. As the MCAH Director Mrs. Evans oversees the Black Infant Health Program, Local Oral Health Program, SIDS Program, Childhood Lead Poisoning Prevention Program and the Comprehensive Perinatal Services Program. Mrs. Evans is also working to ensure that All Children Thrive in the City of Pasadena. As an All Children Thrive (ACT) city, her work is dedicated to achieving transformative changes in the child-serving systems as measured by healthy births, thriving toddlers, and flourishing children who are ready for school, reading at grade level, and succeeding academically and socially.

After attending the 2015 CityMatCH conference, Mrs. Evans worked side by side with the City of Pasadena MCAH Director to engage community stakeholders in addressing the impacts of early-in-life adversity in Pasadena. Through her work she developed a passion for mitigating and eliminating adverse experiences for children, mothers and fathers. In partnership with the Pasadena MCAH Director the department, Mrs. Evans hosted a Call-to-Action: The Impact of Adverse Childhood Experiences, Trauma, and Toxic Stress on Lifelong Health, which brought together healthcare and mental health professionals from across the city and county, featuring speakers from various medical and mental health disciplines. The goal then became for the City of Pasadena to be a Trauma Informed City.

Mrs. Evans continues to work diligently on behalf of infants, children, adolescents, mothers and fathers to improve their overall health, the family unit and the ultimate health of the community. She is a results-oriented detailed professional with a proven track record of fostering great internal and external relationships across multidiscipline areas. At-Large - Ilish Neely, MPH FDC CLC

For almost a decade, I have proudly serviced families in the South Bronx. Currently I operate as a Coordinator of a placed based intervention, The Family Wellness Suite within the New York City Department of Health and Mental Hygiene's Center for Health Equity. Daily I am tasked to coordinate daily operations ranging from fiscal management, program planning, birth justice advocacy and building trust with families of the Bronx. Weekly, I facilitate a parenting class which provide me with the opportunity to revisit my community health worker roots and connect directly with parents. Each week I have the privilege of witnessing their evolution and expansion of self-efficacy attributes, critical to adopting healthier behaviors.



My goal as a coordinator is to craft an environment that promotes health and wellness to traditionally disenfranchised communities. It is to my hope to shift the current Maternal Health narrative to embody more uplifting approaches that support both maternal and infant vitality in addition to mortality review. Often within program planning, I tie together the role mental health and trauma play in the grand scheme of families thriving. As a humble team of two the Family Wellness Suite have serviced more than 600 families in 2018. By June 2019 we will have superseded the previous year's total.

In 2015, I earned my Masters of Public Health with a special concentration on Maternal Child Reproductive and Sexual Health from the City of New York School of Public Health. During the course of my Graduate public health education I worked as a Community Health Worker which, proved to be an eye opening experience. For close to four years I clocked in over 200 home visits where families allowed me into their homes to discuss preparing for birth, newborn care, postpartum depression and a myriad of other health topics. Years later, the on the ground experience remain to greatly shape the way in which I practice public health today. The images, stories, triumphs and challenges of local families inspire me to create thoughtful programming through a health equity lens within the Family Wellness Suite in addition to any citywide collaborations with community partners.

Throughout the course of my career I have been afforded the experiences including public health leadership development, collective impact training offered by CityMatCH. It was through the supportive CityMatCH CityLeader's program where I learned techniques to craft my own leadership style and emerge under the tutelage of seasoned national MCH leaders. In this work Partnerships are key and with the help of CityMatCH I was able to dive deeper into the world of Collective Impact and employ it every day within the Maternal Health arena.

If selected as the North East representative to the Board of Directors, I will bring forth innovative ideas to further the practice of public health while staying on the pulse of Maternal Health trends. It would be an honor to serve as an inspiration, motivator and guide to the next generation of health professionals.



At-Large - Angela Newman-White, MA

I was introduced to maternal and child health in 2005 when I became a Case Manager for the MomsFirst program, a healthy start initiative addressing racial disparities in infant mortality. Within 6 months of my tenure, I joined the MomsFirst administration team at the Cleveland Department of Public Health initially providing quality assurance and training for the citywide program. I was later able to lead and design projects, engage community members to inform programming, and advocate for our families at a state and national level.



In 2011, I joined the Cuyahoga County Board of Health as a Grants Supervisor.

This position allowed me to expand my reach with the MCH population, providing oversight to multiple maternal and child health programs that include infant mortality, teen pregnancy prevention, and childhood obesity prevention initiatives. I have helped to lead our local Ohio Equity Institute's team, the Cleveland Cuyahoga Partnership, which steered the county's effort to increase capacity to provide CenteringPregnancy, an evidence based group prenatal care model, from 2 locations in 2013 to 12 locations in 2019.

I have been a CityMatCH member since 2013 and have had the pleasure of serving as a Peer Mentor in addition to participating in the Collective Impact Learning Collaborative. This effort, One Community, accomplished a 60% reduction in infant deaths in the 44128 zip code through community driven strategies that included breastfeeding support in churches, community building opportunities, and advocacy for labor and delivery services on the county's east side.

Over my career I have provided direct service to children in foster care, adults with a mental health diagnosis, and pregnant and parenting families. I have designed and implemented successful programs and participated in policy reform efforts to address structural and institutional racism. My most recent appointment was to the Cuyahoga County Children and Family Services Community Advisory Board, charged with developing recommendations to improve outcomes for children and families who are served through the county's system.

I hold a Masters of Arts in Sociology, the study of the development, structure and function of human society, from Cleveland State University. I lead with my heart and pride myself on my authenticity and commitment to ensuring that all people have the opportunity to be healthy and successful, regardless of their race, gender, or income. If elected, I hope to work with CityMatCH partners to improve opportunities for families by addressing social issues and conditions that have historically disadvantaged minority populations through community informed policy and program development.



At-Large - Kimberly N. Seals, MSPH, MPA

Ms. Kimberly Seals is the Director of the Bureau of Maternal and Child Health with the South Carolina Department of Health and Environmental Control. As Director, Ms. Seals, oversees activities within the Divisions of Children's Health and Perinatal Services, Women's Health, and the Division of Children's and Youth with Special Healthcare Needs. Prior to relocating to South Carolina, Ms. Seals, was the Maternal and Child Health Director for the March of Dimes Alabama office. In this role Ms. Seals led the state's programmatic and mission related activities of giving every baby a fighting chance. One of Ms. Seals largest initiatives was to launch and implement Healthy Babies are Worth the Wait in Alabama as well as Texas, where she got her start with the organization.



Her work in the nonprofit sector also involved several statewide initiatives such as "Go Before You Show" which focused on increasing early entry prenatal care. She led several 17P educational initiatives for providers and women to prevent subsequent preterm births and collaborated with Medicaid Managed Care Organizations around the U.S. to promote positive maternal health outcomes. Ms. Seals also served as a Public Health Advisor for the Centers for Disease Control and Prevention in Atlanta, Georgia in the Division of Global Migration and Quarantine. As a field assignee for the Galveston County Health District she worked as an Epidemiologist, managed breast and cervical cancer program and investigated communicable diseases outbreaks.

Kimberly received her Master of Public Administration degree from Texas Southern University and her Master of Public Health degree from Meharry Medical College. She completed her undergraduate work from University of Alabama at Birmingham, with a bachelor's degree in biology. Ms. Seals participates on several committees across the state of South Carolina and is passionate about racial/ethnic disparities research and evidenced-based programs.
